Prior to joining Ecologic Institute, Sandra Cavalieri worked at [The Nature Conservancy](#) [10] (TNC) where she collaborated with state agencies ([North Carolina Wildlife Resources Commission](#) [11] (NCWRC) and [North Carolina Division of Parks and Recreation](#) [12]) as well as federal agencies ([US National Oceanic and Atmospheric Association](#) [13] (NOAA)) to secure public funding for biodiversity and landscape conservation.

Sandra Cavalieri holds Master's degrees in both Public Administration and Natural Resources Policy from North Carolina State University, as well as a Bachelor in Religion and Environmental Science from Barnard College, Columbia University.
