In response to the financial crisis, Brexit and the overall disagreement over migration policies, EU institutions and national governments have engaged in an all-encompassing conversation about reforming the EU. Irrespective of the policy field, the question we need to ask ourselves is: How much integration do we want and what are we willing to do for it, both as nation states and collectively as a union?

Climate and energy are exhaustive global policy fields that cannot be kept within the limitations of national borders and strategies. Therefore, any debate on the reform of the EU will impact climate actions and energy policies, and vice versa. While some member states are taking the lead in the conversation, others are merely mirroring the specificities of their national and regional context.
