- Manage and implement research projects for clients from Germany and the EU, including overseeing communication with project partners and clients.

- Relevant Master's or PhD degree in e.g. environmental science, nature conservation, geoecology, geography, landscape/urban ecology, or environmental governance.
- At least 5 years of relevant work experience, including project management and acquisition (administration and content development).
- ✓ Strong knowledge of German and European biodiversity policy (e.g. EU Nature Directives, Natura 2000 network, EU and DE Biodiversity Strategies, Draft Nature Restoration Law, Aktionsprogramm Natürlicher Klimaschutz) as well as of associated financing instruments.
- Comprehensive understanding of key biodiversity threats, trends and interdependencies with other land uses, and related governance and policy approaches, challenges and opportunities; knowledge of different ecosystems, especially peatlands and urban ecosystems, is beneficial.
- Experience in project design and implementation in multi- and transdisciplinary teams.
- Ability to work well both independently and in teams on several projects in parallel within a highly dynamic and international environment.
