COBALT Opening Conference Report: What can we learn from existing needs and perspectives in relation to sustainable raw materials management in Europe for joint future action?

The **opening conference** of the COBALT project, held on November 28-29, 2013 in Brussels, helped exploring different views and establishing an open, respectful multi-stakeholder dialogue. More than 80 participants from all over Europe attended the event and engaged into this dialogue on future options. The debate highlighted that

- sustainable raw materials management will require integration of different and differing priorities present in the discourse, such as
 - o increasing recycling, substitution and more sustainably using domestic mineral resources
 - o and reducing virgin material consumption within Europe,
- looming challenges, e.g. increasing resource scarcities and environmental degradation, will likely cause shifts in priorities in the future
- so that therefore an inclusive and respectful dialogue is needed to openly debate critical issues and to form new partnerships in order to take sustainable raw materials policy implementation forward.

COBALT report on mineral raw material related education

The COBALT report "Education Related to Mineral Raw Materials in the European Union" has now been released. The publication constitutes a preliminary report on available study programmes and skill shortages related to the EU mineral raw materials sector.

The main contribution of the report is a **comprehensive mapping of higher education study programmes in the European Union, within fields related to the raw materials value chain.** The educational offers are compared against industrial activities within various regions and put in context with national and EU-level strategies and policy objectives. This enables an evaluation of the relationship between educational supply and industrial demands. The availability of education is mostly found to correspond to the needs of local industry, but some notable regional imbalances could also be identified. A few educational institutions

have the ability to address cross-value chain skill and knowledge issues, but in most EU Member States this capacity is missing.

Further work will be focused towards development of syllabi and planning of training courses to overcome the knowledge gaps and skill shortages identified during the mapping phase.

First COBALT EU Civil Society-Industry Dialogue, "Ecodesign and New Business Models in a Circular Economy", Brussels, 27 February 2014

The first COBALT EU stakeholder dialogue will take place on 27 February 2014 in Brussels. It will bring together key stakeholders to explore the role of both ecodesign (and specifically design for reuse and recycling) and new business models in enabling more efficient product and resource management, extending product lifetimes, and promoting a circular economy.

This first EU Dialogue will feature presentations from industry and civil society, as well as case studies on innovative approaches to reducing material use and promoting a circular economy. The dialogue will also provide ample opportunity for participants to exchange perspectives and to begin investigating possible pathways for collaboration.

Upcoming COBALT EU and Regional Dialogues

2nd EU Dialogue on Urban Mining in Bergamo (IT) in May 2014, following the Symposium on Urban Mining

1st Regional Dialogue in June 2014 in Madrid

Throughout the COBALT project, three European and three regional-level dialogues will be organised in order to foster debate and exchange between key stakeholders, particularly those from industry and civil society. EU-level dialogues will address key broad themes of relevance to raw material use – besides ecodesign and new business models, participants will exchange on urban mining and producer responsibility, as well as new technologies and community engagement during materials extraction. The second EU Dialogu is planned to take place in Bergamo, Italy, back-to-back with a Symposium on Urban Mining. The Regional dialogues, which will take place in Spain, Sweden and Romania, will shed light on relevant issues of regional importance. The first Regional Dialogue will take playe in Madrid in June, 2014.
