1 Aim of the paper

Within the past two decades, a large increase in the number of environmental institutions and Multilateral Environmental Agreements (MEAs) has raised a debate among academics, policy makers and members of civil society on the practical consequences of such a trend. According to some, the number of institutions involved in international environmental policy making has become so large that the environmental regime inevitably becomes less effective. In fact, an abundance in negotiation forums, implementation efforts and financing schemes can create overlapping and even conflicting policy agendas. From this perspective, the rise in the number of environmental institutions can be seen as a source of inconsistency within the implementation, enforcement, and rule-making processes of the environmental governance system. Consequently, it has been argued that the resulting lack of co-ordination represents one of the major challenges of international environmental governance.²

The search for an optimal level of centralised governance has been the source of a wide theoretical debate. Both centralised and de-centralised regimes entail certain advantages and disadvantages when issues of financing, implementation and negotiation are considered. This paper seeks to contribute to the growing debate about the search for the optimal level of institutional centralisation of the global environmental regime by providing maps that illustrate the spatial dispersion of the various institutions. Overall, such an effort serves the purpose of providing a geographical overview of the level of decentralisation from which global environmental policy suffers, while questions concerning the optimal level of centralisation and the extent to which spatial reorganisation is necessary still remain unresolved.

The paper will begin with an overview of the institutional context within which environmental matters are dealt with on the global scale. From there, the concept of institutional fragmentation will be developed in an attempt to assess the consequences of the rapidly growing environmental regime. In this section, two concepts that are particularly relevant to a geographical analysis of fragmentation will be presented and discussed: clustering and co-location. Providing an additional perspective on the debate, the paper finally unveils several thematic maps showing in detail the current distribution of environmental institutions around the globe.

2 Background

Since the Stockholm Conference in 1972³, the international community has created a large number of bodies and instruments to tackle environmental degradation at a global scale.⁴ In particular, the number of MEAs has grown tremendously and still continues to grow. Currently, the number of environmental treaties surpasses the score of five hundred.⁵ Furthermore, other international bodies have integrated environmental concerns into their agenda and also work on environmental issues within their mandate. Presently, the system of international environmental governance is characterised by the following main institutions:

- As the principal actor for the environment within the United Nations, UNEP is entrusted with responsibilities for policy co-ordination, as well as for capacity building and technical support to developing countries. UNEP also supports international negotiations on environmental issues and provides credible scientific information. UNEP has several regional offices and centres for scientific research.
- The **Global Environment Facility** (GEF) has been established as the main financial mechanism for projects and programs that protect the global environment. Since 1991, the GEF has provided \$ 4.5 billion in grants and generated \$ 14.5 billion in co-financing from other partners for projects in developing countries and countries with economies in transition.
- The United Nations Commission on Sustainable Development (CSD) was created as a forum to ensure the effective follow-up of the United Nations Conference on Environment and Development in 1992. Also, it monitors and reports on the implementation of the Earth Summit agreements at the local, national, regional and international levels.
- Additionally, more than 30 UN agencies and programmes, such as FAO, UNDP, WHO, World Bank, UNESCO, ILO, as well as various institutions outside the UN, have stakes in global environmental politics and sustainable development.
- Several hundred MEAs have been adopted in the course of the last decades.
 They introduce a wide set of rules, covering various areas of environmental
 policies. Several MEAs provide financial resources for capacity building,
 technology transfer and the creation of scientific knowledge.

A search on the ecolex website, <u>www.ecolex.org</u>, which is a database sponsored by UNEP, FAO, and IUCN, yields a total of 519 environmental treaties. Many of these are defunct, as is evident from the list in the Annex.

Due partly to the fact that inter-linkages were not considered as the environmental treaties were being negotiated⁶, the co-ordination of policies within this multiform governance context has become an arduous task. Moreover, as the system grows, there is an increasing risk of institutional overlaps, occasionally creating situations where agendas of certain MEAs and international environmental bodies actually conflict with each other while synergies in the implementation and financing processes are not exploited. The following chapter will take a closer look at the consequences of this apparent lack of coherent governance.

3 Fragmentation of Environmental Governance

Many accomplishments have been made under the current system of international environmental governance, the most notable of which are the successes related to issues such as ozone depletion, hazardous wastes, bio-safety, and even climate change, with the recent ratification of the Kyoto Protocol.⁷

However, despite the many achievements of the international environmental governance system, many ecological problems which affect the livelihoods of humans and ecosystems around the world continue to worsen. Improved governance, notably with regards to the overall co-ordination of international policies, is often cited as a necessary step for a renewed fight against ecological deterioration. Institutional fragmentation represents one of the centrepieces of the debate about the shortcomings of environmental governance.⁸

In an attempt to offer a coherent conceptualisation of the process, Felix Dodds presents institutional fragmentation as a phenomenon occurring in two dimensions: the vertical (from local to national, regional and global), and the horizontal (within a governing structure). In such a conception, the fragmentation of environmental institutions not only relates to issues of geographical dispersion, but also to such problems as inconsistency of norms and rules, and of differing political and normative contexts. Fragmentation thus relates to discrepancies and overlaps between the agendas of thematically equivalent regional and world-wide bodies as much as it relates to problems of duplication of work between global institutions with very different agendas. The main deficiencies brought about by the fragmentation of the environmental regime are summarised below:

- Institutional overlap: On the horizontal level, fragmentation leads to a
 duplication of work and a failure to identify synergies among the various
 departments. On the vertical level, the balance between regional and international
 treaties is not always easy to find and can also lead to a considerable amount of
 overlap on environmental issues.
- **Conflicting agendas:** In some cases, the overlap has actually gone so far as to evolve into a conflicting situation. This was particularly relevant during the Kyoto negotiations, as the overlap with the Montreal Protocol gave rise to a situation where the same gases were being regulated in conflicting ways under both Protocols.¹¹
- High travel costs and administrative expenses: The multiplication of MEAs increases overall costs for the member countries, as financial and human resources are stretched by a growing number of meetings, negotiations, reporting requirements, etc.
- **Reduction in state participation:** Following up on the financial and human resources considerations, it has been recognised that the fragmentation of the international environmental system has brought about a reduction in state participation. Due primarily to the proliferation of demands stemming from the growing number of MEAs, developing countries have become less willing to engage in further agreements.¹²
- Continued reluctance of some agencies to co-operate: Agencies often remain inward-looking and are averse to the idea of sharing or giving away part of what they perceive as being their domain. Such an attitude, combined with the increase in the total number of agencies, can further exacerbate the problem of lack of co-operation.

While the fragmentation process presents many disadvantages to the environmental regime, there are also some noteworthy elements which can be seen as being positive:

- **Specialisation:** Fragmentation might mirror the specialisation required for dealing with many environmental issues. Indeed, each treaty gathers experts and specific knowledge which is tailored to a given problem, and which in turn might suffer from too much centralisation.
- **Innovation:** The institutional expansion of the environmental governance regime can lead to increased competition between the various agencies, thereby fuelling innovation in the policy field.¹⁴

- Visibility: The widespread presence of institutions around the globe has the notable advantage of increasing the overall visibility of environmental governance. Gains in public awareness and political will can be seen as positive consequences of the widespread presence of environmental institutions.
- Ownership: Host countries of MEA secretariats might develop a particularly strong will to support the further development of the agreement.

While the debate on the optimal structure of the international environmental system remains undetermined, there is growing support for the need to address fragmentation. 15 An increased centralisation of the regime is thus seen as a step in the right direction. Indeed, it appears as though the advantages of having a lessfragmented regime outweigh the disadvantages associated with having a more centralised governance structure. In this debate on institutional reform, the concepts of clustering and co-location are often cited as possible strategies for improving the co-ordination efforts among MEAs. The following section will take a closer look at these two notions.

Clustering

Clustering can be defined as "a 'tool of coherence', which, when translated into structures, processes and methods of work, shall bring greater policy and programmatic consistency in the work of the MEAs". 16 Such a process serves the purpose of integrating international environmental institutions into a structure which is more adequate for exploiting missing synergies, reducing administrative burdens on the Member States, fostering staff exchanges, increasing co-operation between relevant decision-makers, and providing savings in financial and human resources.

Clustering can take on several forms, and can be grouped into three categories depending on whether they address theme-based, functional/administrative, or geographical fragmentation:

- **Theme-based clustering:** Under this approach, several proposals exist for creating thematic clusters. For example, a UNEP conference report proposes five groups:
 - atmosphere conventions;
 - biodiversity-related conventions:
 - chemicals and hazardous waste conventions;
 - land conventions; and

- regional seas conventions and related agreements.¹⁷
- Functional/administrative clustering: Proposed groupings in this category are articulated around the following elements:
 - capacity building for assessment;
 - risk assessment and subsequent decisions-making;
 - implementation and compliance at the country level;
 - awareness raising and education; and
 - common problems of the trade related MEAs (such as CITES, the Montreal Protocol, and the Basel Protocol).¹⁸

More specifically, monitoring and reporting efforts are expected to be facilitated by a grouping of organisations. Also, common departments of the secretariats, such as event management and human resources, can be targeted for clustering.

• Geographical clustering: At the geographical level, clustering refers to the creation of institutional hubs. More specifically, increased co-operation is expected to result from the merging of agencies under a common roof or within the same city.

"Geographical clustering" is particularly relevant to our analysis, as it brings attention to the spatial dispersion of environmental institutions. The location of the various agencies has a concrete effect on global environmental policy, as efforts in international co-ordination depend heavily on the level of communication between the various offices. Other factors, such as the availability of human resources, public participation, political visibility, and international equity also play a role in this debate.

Following up on these geographical considerations, the next section will take a closer look at the implications of co-locating the secretariats of MEAs.

Co-location

In an effort to reduce the wide distribution of environmental agencies, it has been proposed to locate environmental institutions together. Thus, co-location is particularly relevant to the grouping of MEA secretariats into a particular city or place. Although proximity does not by itself automatically lead to an increase in co-operation among agencies, the geographical convergence of environmental institutions is believed to help facilitate co-ordination efforts and exploit potential synergies. The main advantages of co-location are highlighted below:

Reduction in overall operation costs: Less travelling and co-ordination costs will consequently reduce the overall costs of participation in treaty negotiations.¹⁹

- Participation of developing countries: Following up on the financial argument, co-location also has the potential to increase the participation of developing countries in MEAs, as developing countries suffer so far most from the high costs related to the attendance of many events (some of which also occur simultaneously).
- **Increased co-operation:** By exploiting missing synergies and facilitating information and resource sharing, problems of administrative burdens and treaty congestion could be alleviated.
- **Joint meetings:** More opportunities for regular meetings between a wider range of scientific and technical experts can be expected with closer contact among the agencies.
- **Conflict Resolution:** Less distance between secretariats will facilitate a prompter reaction to and resolution of conflicts between the various agencies.

Despite these promising considerations, co-location can also present some negative aspects as well, namely:

- Uncertainty: It still remains to be proven that the costs associated with colocation and geographical reorganisation will provide enough benefits in terms of overall efficiency.
- Political resistance on behalf of host countries: There is a significant political challenge in the effort to re-organise the distribution of secretariats. Indeed, there is quite a bit of competition among the host countries for the political visibility and the economic spill-over effects. Accordingly, some authors state that the co-location of secretariats "is known to face serious political resistance and is therefore unlikely to succeed".²¹
- Equity: Although it may be more efficient to group more conventions into a
 city that already hosts a variety of international institutions, such as Geneva,
 New York, Paris or Bangkok, equity becomes a factor when you consider the
 loss that other less-developed locations would suffer if a Secretariat were to
 move out.

In conclusion, it is believed that co-location of MEA secretariats would have the potential to 'provide efficiency gains, increase cross-treaty communication, and deter from MEA fiefdoms'. Still there is no consensus on how best to design an

institutional framework that is most efficient and effective for dealing with the complexities of environmental issues at the international level.²³

4 Geographical Distribution of MEAs

This theoretical exploration of clustering and co-location as means of addressing the negative effects of fragmentation has highlighted two concepts which have a strong spatial connotation. In order to highlight the scope of the geographical fragmentation of the global environmental regime, the following section shows maps of the MEA secretariats based on an inventory we collected from various sources.²⁴ This enterprise was undertaken in an effort to move beyond the long-standing debate on the optimal structure of the international environmental governance system by offering a concrete representation of the current status of institutional fragmentation. While some authors have begun to use maps to demonstrate the geographical aspects of the debate, these usually do not offer much detail.²⁵

With the following maps it is attempted to move this process further by offering a complete charting of all secretariats. In addition, the maps provide a thematic breakdown of the many institutions. Thus, clusters can be assessed not only on a spatial dimension, but also on a theme-based level. The secretariats have been arranged into the five thematic clusters discussed above: atmosphere conventions; biodiversity-related conventions; chemicals, hazardous substances and wastes conventions; land conventions; and water conventions. There is a total of six maps, one for each category and a final one that combines all of them. He must be kept in mind that MEAs vary extremely in regard to membership, geographical scope, financial resources etc.

Nevertheless, the maps offer academics and policy makers an illustration of the extent to which the environmental regime has become fragmented. Hopefully, the debate can evolve from there into more substantial considerations about the best



Sources of the MEAs and their Secretariats were mainly twofold: The one major source used was the "Treaty Locator Page" (online at: http://sedac.ciesin.columbia.edu/entri/index.jsp). This page clusters MEAs according to their thematic issues. Also, it contains indications of the "year of agreement", "year of entry into force", "signatories", "total parties" and "former parties". The data were integrated into a spreadsheet. Afterwards, names and locations of the MEAs' secretariats were identified. This was mainly done with the help of the website, http://iea.uoregon.edu/index.htm. In the event that no information on a particular secretariat was found within these two sources, further internet research or direct contact with international organisations was undertaken.

The reference for the map is the following: "Map nr. 41,70 Rev. 5, united nations, department of Peacekeeping operations, Cartographic Section, January 2005". Because the points on the map are not drawn to scale, they fail to offer a very detailed representation of the locations. This is particularly relevant in the case of Central Europe. However, the exact location of the Secretariat can easily be determined by consulting the table.


4.1 Secretariats of conventions related to the protection of the atmosphere




4.2 Secretariats of conventions related to the protection of biodiversity




4.3 Secretariats of conventions related to Chemicals, Hazardous Wastes & Substances




4.4 Secretariats of conventions related to the protection of Land
